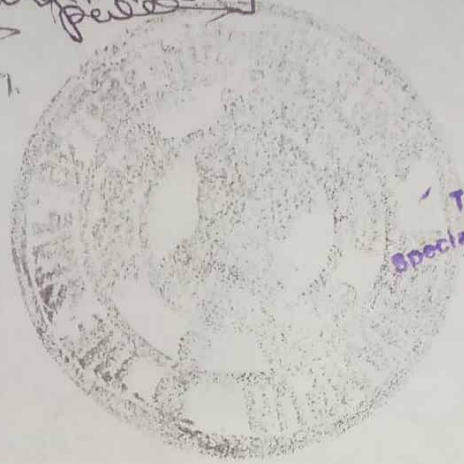

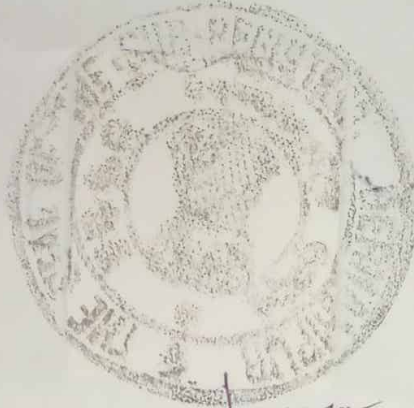

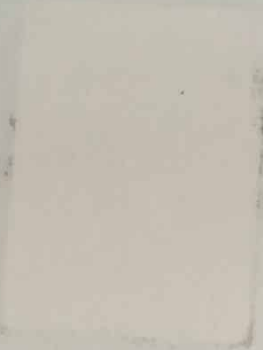

1. WHEREAS, the above named continuing trustees along with the vacating Trustees and one Sri Epari Tejeswar Rao have made and declared a Trust under the name and style of "Takshashila Educational Trust" on due declaration and execution of the Trust Deed on various stipulations and with due attestation by the attesters under registered document bearing No.77/2002 Dt.14.03.2002 duly entered in Book No.IV, Vol. No. 113, from pages 127 to 140 of the Office of Sub-Registrar, Berhampur [Rural] and subsequently reconstituted the above declared Trust by other Regd. Document No.217 of 2002 Dt.28-09-2002 of Book-IV, Vol.110, Pages 343 to 364 of the Office of Sub-Registrar, Berhampur Town when said Sri E.Tejeswar Rao vacated from the said Trust, and the reconstituted Trust continued till date by the above continued and vacating trustees hereof smoothly, and
2. WHEREAS, the above declared trust has founded and floated Residential School under the name and style of Takshashila Residential School by forming a Managing Committee for its day-to-day management, and
3. WHEREAS, the Vacating Trustee Mrs. Epari Swarnalata being a female burdened with her house hold duties and son's education besides the Original Trustee Smt.Neeta Nandita having got married now and going to settle with her husband at Hyderabad, both of them not being able to perform or discharge their duties as Trustees of the Trust and its Institution, hereafter, they individually conveyed and expressed their desire and decision to retire and vacate from the respective Trusteeships and its Institution and ultimately they suomoto resigned and vacated their trusteeships of the Trust, requesting the Trust Board to accept the same and to relieve them from the Trust perpetually, and

WHEREAS, in consultation and mutual deliberations amongst all the Trustees in presence of the Incoming Trustees Sri Pawan Kumar Choudhury and Sri Rabi Sankar Choudhury in the Board meeting, the existing Trust Board unanimously accepted the resignations of those Vacating-outgoing Trustees and thereby declared that Smt. Neeta Nandita and Mrs. Epari Swarnalata – the Vacating Trustees herein ceased from their Trusteeships and membership without themselves having any claim or interest hereby giving up and relinquishing their rights, powers, privileges and interest absolutely the Trust, its school and Takshashila Educational Trust property with immediate effect and in consequence accepted the joining of the new Trustees as proposed by the Trustees with their consent in place of those vacated Trustees and as a result, the properties, assets and powers, rights, interest of Trustee under the Trust Deed vested and passed also to the newly taken Trustees as above since the vacated Trustees absolutely ceased from the same. The Power of Authorization given earlier by the vacating Trustee Smt. Neeta Nandita to her father Sri E.T. Rao is revoked and cancelled by her, and
5. WHEREAS any acts, deeds, transactions, dealings if any lawfully made by the vacating Trustees Smt. Neeta Nandita and Mrs. Epari Swarnalata, in regard to the Trust, its Takshashila Residential School and of its committee prior to this document are binding on the Trust and in case of any further activities or dealings if any committed by the said Vacating Trustees on behalf of the Trust or its School shall be unlawful and illegal and the same shall not bind the Trust or its School and Continuing Trustees, and
